# INFORMATION REQUIRED TO APPLY FOR A <u>COMMUNITY BUILDER LOAN</u> AT THE TIGUA COMMUNITY DEVELOPMENT CORPORATION

The Tigua Community Development Corporation (TCDC) is the tribal loan company that provides loan products and services to the Ysleta del Sur Pueblo community.

### **Application Process**

Submit the completed application package with required supporting documents to Melissa Senclair, Credit Administration Assistant. Once they have been reviewed, Martin Sena, Business and Lending Manager will contact you to schedule an appointment to go over the application. The Tigua Community Development Corporation is located at the Tigua Technology Enterprise Center, 9180-B Socorro Road, with regular business hours of 8:00 am to 5:00 pm, Monday through Friday.

### Supporting Documentation Checklist\*

1.	Proof of income: Your 3 most recent payroll stubs or your benefits/pension	
	payments letter etc. Include all money received;	
2.	<u>Bank statements</u> : Provide 2 months of complete bank statements for every account you have (if you do not have a bank account, please tell us);	
3.	Most recent personal tax return (include complete tax return with all schedules and W-2 statements);	
4.	Provide a copy of Enrolled Ysleta del Sur Pueblo Tribal Member Card, and a copy of	
	Driver's License or Government I.D.;	
5.	A completed Community Loan Application and budget sheet, as provided on	
	pages 1-3; and	
6.	Your most recent credit card statement(s) or other loan repayment(s) statements if	
	applying for a debt consolidation loan.	

### The following are allowed reasons for use of money:

- Credit building and credit repair
- Debt consolidation (i.e. pay off finance company loans, credit cards, or other debt accounts). For any debt account considered for consolidation, the pay off or payment is made directly to lender/creditor.
- Auto repairs or purchase (the loan may require collision insurance if the auto title is required as collateral by the TCDC);
- Traffic citations, reinstatement fees, surcharges and warrants.
- Home appliance or furniture;
- Other reasons for household or family expenses are considered and evaluated.
- At this time, the TCDC does not lend money for home improvements or renovations.
- The maximum loan amount for a Community Builder Loan is on a case-by-case basis along with the term. Business and Lending Manager will discuss your options.
- A loan application is subject to approval. Upon approval, a \$30.00 application fee applies.
- If a Community Builder Loan is granted, the borrower(s) is required to participate in a financial literacy education class to be scheduled at the Tigua Technology Enterprise Center located at 9180-B Socorro Road, or other venue, provided by the Department of Economic Development. (The financial literacy class is available to all tribal members.)
