



## Ysleta del Sur Pueblo Chilicote Ranch Guidelines

The Chilicote Ranch is owned and operated by the Ysleta del Sur Pueblo Tribe of Texas. All individuals utilizing the ranch facility must acquire authorization prior to arrival recognizing that they are guests of the Tribe and therefore agreeing to abide by the rules, regulations and procedures. The Ranch, with its facilities, offers an excellent opportunity for relaxation, as well as exposure to nature and recreation. The facilities include a lodge, a swimming pool and a wide range of areas reserved for seasonal hunting. Upon arrival, please notify Arturo (Tury) Loera at (915) 494-4089. You will be welcomed and oriented on the facility, ensuring that the lodging facilities are presentable and clean and that there are linens and adequate bathroom toiletries available.

If an accident should occur or in the event of any equipment or furniture damage/breakage, please provide Tury Loera with immediate notification, so that repairs can be scheduled in a timely manner.

## **Utilization of Lodge Facilities**

- 1. Only those individuals with authorized permission may utilize the lodging facilities. This applies to both tribal and non-tribal members.
- 2. Availability of the facilities shall be determined solely by the Tribe and may be subject to change at any time. Weekends shall be awarded by raffle; to reserve weekday visits, please contact the YDSP Department of Public Safety at (915) 860-7155.
- 3. All guests of the facilities must abide by the rules and regulations, which are posted on the premises. These rules and regulations govern the proper conduct you and your guests should follow and also specify the activities that are permissible on the property.
- 4. You and your guests are responsible for the physical condition of the areas that you utilize; therefore, you will be held liable for any/all damages that may result on the property.
- 5. You and your guests are also responsible for any personal property brought to the Ranch; therefore, the Tribe shall not be responsible for lost, stolen, or damaged personal property.
- 6. Any activities engaged by you and your guests are performed at your own risk and the Tribe will not assume liability for personal injuries, death, or property damage resulting from your personal activities.
- 7. Children/minors should never be left unattended and should remain under your supervision AT ALL TIMES, <u>especially in</u> the swimming pool area.
- 8. Utilization of the swimming pool should be pursuant to the posted rules and regulations and let it be known that Ranch Management does not provide lifeguard services; therefore, all swimming activities are performed at your own risk.
- 9. All Hunting activities are governed by Texas State Law. Hunting should ONLY be engaged in during the seasonal period identified for hunts. Guests must abide by all applicable laws and regulations pursuant to the procedures propagated by the Tribe.
- 10. All vehicles shall be operated and parked only in roadways and parking areas designated by the Tribe. Vehicular traffic is prohibited in all other areas of the Ranch not designated as set forth above.
- 11. No firearms shall be brought onto the Ranch property, except by guests who are engaging in authorized hunting activities with express permission of the Tribe.
- 12. No pets or other types of animals shall be brought onto the Ranch, unless previously authorized by the Tribe.
- 13. No ATV (all-terrain vehicles) or motor cross bikes are allowed onto the Ranch at any time.
